Minutes of the Parish Council Meeting held at Mentmore Village Hall on Wednesday 12th February 2020 at 8.00pm.

C/001/20. Chairman's items and welcome.

The Chairman opened the meeting and welcomed everyone.

C/002/20. Attendance and Apologies.

Apologies were received and accepted from Bucks County Councillor Anne Wight and Councillor lain Butler.

C/003/20. Disclosures of Interest on items pertaining to the agenda – Councillors to declare any interests.

Councillor Langley declared an interest in an invoice submitted for payment and a quotation to repair the Village Green bench.

C/004/20. Minutes from previous meeting.

It was PROPOSED BY Councillor Langley, SECONDED BY Councillor Dack and APPROVED and carried unanimously that the minutes from the parish council meeting held on the 4th December 2019 were correct and were signed by the Chairman.

C/005/20. Public Question Time.

A resident thanked the council in particular the Chairman and Councillor Fletcher for their work on the council with a planning matter.

C/006/20. Police Matters.

Not present.

C/007/20. Reports from District and County Councillors.

Bucks County Councillor circulated her report prior to the meeting which covered Unitary and the process for reporting illegal encampments. The report will be kept with the minutes.

AVDC District Councillor Cooper gave his report about the new Buckinghamshire Council.

Buckinghamshire Council Scrutiny Committee had the opportunity to interview the Leader and Exec of the shadow council and to review the budget for the first three years of the five-year term of the new Council. The recommendations from the committee will go to the full council and a budget will be approved at the full council meeting. The new Buckinghamshire Council have prepared a business plan which is available on the website. The scrutiny committee has recommended that climate control is included and has a budget.

Council tax needs to be harmonised across the county, AVDC is currently in the middle.

C/008/20. Village Hall and Village Green.

The Chairman invited a member of the public to speak. The resident explained that a few parents have requested play equipment for smaller children and a discussion took place. The resident and Councillor Langley will carry out some research and prepare a proposal.

It was agreed to repair the oldest bench on Mentmore Green at a cost of £60.

It was agreed to accept the quotation from MK Flooring for £490 plus VAT.

It was agreed to renew the Performing Rights Licence for the Village Hall at a cost of £173.83 plus VAT. It was agreed to accept the revised quotation for the audio-visual system is higher than expected and will cost £1057 plus installation approx. £400.

It was agreed to spend up to £2,300 plus VAT to repair two Village Hall windows by DLS Carpentry and for the windows to be painted when the repairs are complete.

C/009/20. High Command Production donation of £2,500 to Mentmore Parish Council.

The donation will cover the audio-visual equipment for Mentmore Village Hall and be used towards the new play equipment.
