Minutes of Mentmore Parish Council meeting held on Wednesday 5th December 2018 at Mentmore Village Hall at 8pm.

C/130/18. Chairman's items and welcomes

The Chairman opened the meeting and welcomed everyone.

C/131/18. Attendance and Apologies

Apologies were received and accepted from Cllr lain Butler.

C/132/18. Disclosures of Interest on items pertaining to the agenda – Councillors to declare any interests.

Cllr Langley declared a pecuniary interest in the following agenda items: accounts for payment, LED lighting work, devolved services re-tendering, Village Hall redecoration and application of wood preservative in the parish.

C/133/18. Minutes from previous meeting.

It was PROPOSED BY Cllr Dack, SECONDED BY Cllr Langley and APPROVED and carried unanimously that the minutes from the parish council meeting held on the 3rd October 2018 were correct and were signed by the Chairman.

C/134/18. Public Question Time.

Ledburn – two members of the Ledburn community reported the area's BT home phone service is very poor and unreliable and with no mobile phone signal and recently the BT public phone box has been removed. AVDC District Councillor offered to take this matter to BT as he has been dealing with BT on issues in his village.

Lower Crafton – a local resident will be applying to cut back hedges 4.5m from the edge of the road, he is looking for volunteers to assist with the project. The Chairman said MPC will support this idea but are not a consultee for tree work applications. The resident said road maintenance is shocking with cracks in the road surface, the Chairman asked the resident to take photographs and report on Bucks CC website through their Fix My Street portal.

C/136/18. To receive reports from District and County Councillors.

AVDC District Councillor P Cooper gave his report about unitary and the alternatives the Secretary of State has proposed with possibly 2 or 3 members per division. AVDC recommendation is for 3 members per district but he personally prefers the County's recommendation for 2 members per District which would be a total of 98. All 5 District Councils have asked to delay the Divisional and Parish council elections.

Bucks County Councillor Wight gave her report which included unitary and recommendations for the number of Councillors for the wards. The boundary review is likely to happen in 2024 and be based on the number of new homes planned in the area. The Brownlow bridge will have a 18.5 tonne weight limit.

Cllr Fletcher spoke about the lack of enforcement of HGVs travelling from Cheddington airfield and the damage caused to the verges in the parish.

C/137/18. Village Hall.

Cllr Dack distributed the minutes of the Village Hall committee prior to the meeting. The floor refurbishment and redecoration will be starting on the 7th January. Quotations have been received to replace the hedge and replant the hedge for £550 and cut back the beech hedge for £150 it was agreed PROPOSED BY Cllr Dack and SECONDED by Cllr Brazier Cllr Langley took no part in the discussion.

A working party will be formed to cut back the Lime tree suckers on the village green. The committee want to waterproof the joints in the kitchen which will cost between £150-£200.

The Chairman is going to investigate options to install central heating into the Village Hall and £4000 will be allocated in the budget for this.

It was agreed to renew the licence for Hallmaster at £137.

Due to the single unitary council to be established in 2020 Bucks County Council have only offered a one-year devolved services contract. Therefore, it was agreed that the current contractor Jonathan Langley will continue with grass cutting and other devolved works for a further year until the new council offer is available for future years.

A road-maintenance meeting has taken place between the Chairman and the contractor and the Chairman said MPC can afford two days a month work and the priorities are Ledburn to the bridge opposite The Cottage and Stag Hill. Cllr Dack asked whether a failed road surface sign can be erected, and the Chairman will write to Bucks about this.

Cllr Dack has completed a survey of the footpaths and her report will be forwarded to rRipple to raise with Bucks Rights of Way team.

It was agreed to contribute £125 towards the cost of replacing the old stile at Rosebery Mews with a new gate. PROPOSED BY Cllr Brazier and SECONDED BY Cllr Langley and carried unanimously.

There are concerns over a possible increase in litter through the parish when the new fast food take-away restaurants open in Leighton Buzzard.

The trailer that was fly tipped in Mentmore has been removed.

Cllr Dack reported there will be a community litter pick in April.

The Clerk will contact AVDC to request their contractor includes Ledburn in the monthly litter pick.
